Subject: Meeting with the DVET officials from Government of Maharashtra State for conducting MTTP and TTP for vocational teachers in 2024-25

Following points are discussed in the meeting.

- The Joint Director extended a warm welcome to all attendees and state officials from the Government of Maharashtra. The purpose of this meeting is to discuss and finalize MTTP and TTP for bifocal vocational teachers of Maharashtra State.
- 2) PSSCIVE Bhopal has pre-scheduled DVET program in the month of May, 2024. Hence, MTTP programs for DVET, Maharashtra State will be scheduled in the month of June, 2024. As there is a slot available in the last week of April, 2024 it is decided to conduct MTTP for following 06 job roles and 20 teachers will be participating as a Master Trainer in each MTTP.
  - i) Four-Wheeler Service Technician
  - ii) Auto Service Technician (Two and Three Wheeler)
  - iii) Agriculture Machinery Operator
  - iv) Irrigation Service Technician
  - v) Business Correspondent and Business Facilitator
  - vi) Distributor Salesman

- 3) It is suggested to see the feasibility to conduct following MTTP and TTP in the Maharashtra State:
  - i) Field Technician-Wireman Control Panel ITI / SCERT, Pune
  - ii) Lineman Distribution ITI / SCERT, Pune
  - Dairy Farmer / Dairy Entrepreneur Aarey Dairy, Goregaon, Mumbai
  - iv) Small Poultry Farmer Dr. B V Rao Institute of Poultry Management and Technology in Uruli Kanchan, Pune
- 4) Dr. Deepak Shudhalwar informed that the Field Technician -Washing Machine (Qualification Pack: Ref. Id. ELE/Q3106) has been discontinued by the council and introduced new job role i.e., Field Technician - Air Conditioner.
- 5) It is suggested that the Government of Maharashtra send the letter to PSSCIVE, Bhopal for providing the draft copy or the final copy of the Text books for 19 job roles in the month of June, 2024.
- 6) It is decided that State should depute the Programme coordinator for MTTP and TTP at training venue for financial administration cum coordination.
- 7) Estimated budget for MTTP and TTP is also discussed.

The meeting ended with the vote of thanks to the Chair.
